Photographs, texts and other materials may not be published, sold, publicly or privately advertised or used in any other way without the consent of CAMPING PORAT. Rules on personal data protection on websites

We emphasize that when you visit this website, your personal information will remain confidential, unless you want to make a voluntarily disclosure. We only collect personal information that you voluntarily provide to us, and only for the purposes outlined in these Rules. When collecting personal data, we are committed to comply with the provisions of positive regulations on personal data protection.

Personal data collected from persons who booked accommodation and guests

Personal data recorded by CAMPING PORAT at the time of booking and filling in the registration card at arrival to the facility are collected on the basis of laws regulating hospitality and for the purpose of providing services to guests. These include the following data (subject to change with regard to positive regulations):

- Name and surname;
- Address of residence (Croatian citizens);
- Phone number for contact
- E-mail address
- Date of birth;
- Number, type and place of issue of identification document;
- Nationality;
- Date of arrival and departure of guest;
- Sex.

Sharing your personal data with third-parties

We do not sell, transfer or disclose information that we collect on our websites to anyone outside Cresanka d.d. without your consent, except if processing (1) is prescribed by law and is necessary to comply with our legal obligations, (2) is necessary to protect your life or physical integrity, and you are incapable of giving consent, (3) is necessary for the fulfilment of the tasks carried out in the public interest, (4) if you have disclosed that data yourself, and (5) is necessary for the purposes of our legitimate interests. Your personal information will be stored only for as long as is necessary and for the purposes specified in this notice.

E-mail messages

When you send us an email (by sending an email message with question, comment, complaint, advice or similar, or filling in the contact form on a website) with personal information that may in some way identify you, we will use this information only to fulfill your request. Furthermore, we may forward your email address, as well as the message/request you sent us, to other partners who will be able to best answer to your question.

Cookie policy

This website uses cookies.

Cookies are small text files generated by a website server that are stored by the web browser on user's device, in order to offer better services and contents. Cookies can store certain information (for example, language or website preferences, registration status of the account, etc.) that your browser can reproduce when you return to the website (depending on expiration date of the cookie). Some cookies are essential and enable you to navigate our website and gain full access to our basic services and features.

Information collected by cookies helps us to learn how you use the website, in order to improve the quality and experience of services. Optional cookies we use are Google Analytics cookies (they collect and analyze information on how you use our website, these cookies are used solely for statistical purposes, and do not collect any personal data), and social network cookies that allow you to share specific content through your own account on a social network.

By browsing and continuing to use our website you are at any time aware of and agree to the terms and conditions of use, including the provisions on the processing and protection of personal data and on possibilities in connection with cookies.

Data subject rights

Consent to the processing of personal data is not obligatory, but your refusal to give consent to process personal data as stated above, may make it impossible to use all or some of the contents offered by the website, or prevent to receive information on products or services offered by CAMPING PORAT

By sending personal data to CAMPING PORAT you do not waive your rights guaranteed by positive regulations of the Republic of Croatia that protect personal data, and in particular the right to request a rectification or erasure of your personal data if they are not complete, correct or updated or their processing has not been made in accordance with the above mentioned provisions.

Whereas the processing of your personal data is based exclusively on your consent, you have a number of rights, including:

- a) Right to access:** the data subject whose data are being processed have the right to obtain information about the purposes of processing, the categories of personal data concerned, the categories of recipients to whom the personal data have been or will be disclosed, the envisaged period for which the personal data will be stored and other rights.
- b) Right to rectification:** the data subject shall have the right to obtain the rectification of inaccurate personal data or to have incomplete personal data completed.

c) Right to erasure: in certain circumstances, the data subject shall have the right to obtain the erasure of personal data concerning him.

d) Right to withdrawal: the data subject shall have the right to withdraw his or her consent at any time.

e) Right to lodge a complaint with a supervisory authority: If you believe that your rights have been violated, you have the right to lodge a complaint to the Agency for the protection of personal data (AZOP).

Depending on the request of users/data subjects, CAMPING PORAT undertakes to:

1. Confirm the user as to whether or not personal data concerning him or her are being processed.
2. Rectify or delete the personal data concerning him or her free of charge and without undue delay.
3. Restrict or stop the processing of personal data relating to him or her.
